RULES

There are 10 obstacles. Each obstacle is worth 10 points. Rider has 1 minute to complete each obstacle

Judges will deducting points from a contestant's score using the basic guidelines shown below:

|---------------------|--|
| 1 point | <i>Balk, Hitting pole or any part of obstacle</i> |
| 2 - 3 points | <i>Refusal, Off Course, Letting go of both reins</i> |
| 5 -10 points | <i>Breaking Gate, Knocking part or all of obstacle over, Horse becomes out of control</i> |

Riders must be 12 years and older. Riders younger than 18 MUST wear helmet and have an adult present.

One entry per horse. One entry per person.

No stallions, no ponying, no whipping or beating your horse. Saddles are required by all riders. No dogs allowed.

RELEASE OF LIABILITY

I acknowledge that horseback riding is a sport that carries inherent risks of injury and damage to my horse, my property, others and myself. I knowingly assume all risks, whether known or unknown, of horseback riding.

I hereby release the *Norco Horseweek Committee, Inc.* (hereinafter referred to as *The Committee*) and the City of Norco (hereinafter referred to as *The City*) from all liability for any act of negligence or want or ordinary care on the part of The Committee and or The City or any of its agents.

In consideration of my participating in events organized or sponsored by The Committee, I wave, release and discharge assigns from any and all claims of liability for injury or damage to myself, my animals, or my property arising out of my participation. This agreement is binding upon my executors, heirs and assigns.

I expressly wave any rights I may have under California Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know or suspects exists in his/her favor at the time of executing the release, which if known by him/her might have materially affected his/her settlement with the debtor".

I agree that I will indemnify and hold harmless The Committee and The City, their officers, directors, members and agents against all claims, demands, and causes of action, including court cost, and actual attorney fees arising from any proceedings or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.

The Committee, its agents or employees shall not be liable for any damages which may accrue from any cause or as a result of fire, theft, running away, state of health, injury to person, horse or property.
