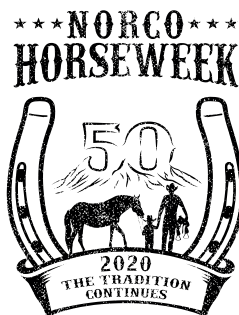

Check in area is located at **6th Street and Corona Ave.** at 8:00 am 'til 9:30 am. Parade Starts at 10:00am sharp. All participants must be on their numbered spot by 9:30 AM. The parade route is up 6th Street to Ingalls Park. **DO NOT RIDE BACK DOWN 6TH STREET TRAIL, TO OR FROM PARADE LINE UP.** Three special awards will be presented.: Theme, Equestrian and Non-Equestrian Sweepstakes. Judging of all classes will be in the line of march at the Circle K at Center Street.

Parade Rules

ATTENTION ALL PARADE PARTICIPANTS

1. Failure to follow the instructions of the Parade Officials shall be cause for disqualification.
2. At no time is any person or unit allowed to hand out or throw anything along the parade route. This creates a potentially dangerous situation between spectators, horses, and vehicles.
3. Distribution or throwing of merchandise or articles by any participant is not permitted along the parade route. **This includes candy, trinkets, etc. Any such activity will result in immediate disqualification.**
4. All units are to keep moving at a safe distance, no gaps please. No stopping to perform.
5. Music groups may not start playing live or recorded music before leaving Corona Ave Start.
6. When finished with the parade route, DO NOT go back down 6th St. Please use 5th or 7th to exit.
